Indian wind turbine maker Suzlon Energy Ltd said on Tuesday it has agreed to acquire a 76% stake in operations and maintenance (O& M) company Renom Energy Services Private Limited in a two-tranche deal that will allow it break into the growing non-Suzlon turbine services market in India.

Suzlon Energy Limited specializes in development, manufacturing and marketing of generation systems of wind energy. Net sales break down by activity as follows: - sale of wind turbines (56.4%): owns, at the end of March 2019, an installed capacity of over 18,000 MW; - operation and maintenance services (35.9%); - sale of casting and forging components (6%).

Suzlon Group, India"s largest provider of renewable energy solutions, has announced the acquisition of a 76% stake in Renom Energy Services Private Limited (Renom) from the Sanjay Ghodawat Group (SGG). The deal, valued at INR 660 crores (USD 80 million), is set to be completed in two phases.
