Will Cairn change its name to Capricorn Energy plc?

Cairn plans to change its company name from Cairn Energy PLC to Capricorn Energy PLC, effective from 13 December 2021. The LSE stock ticker will remain as CNE. This follows an agreement at the time of the Cairn India IPO that the name would ultimately be changed.

Where does Azerbaijan rank in energy architecture?
