#### What is a lithium battery?

Lithium Battery - The term "lithium battery" refers to a family of batteries with different chemistries, comprising many types of cathodes and electrolytes. For the purposes of the DGR they are separated into: Lithium metal batteries. Are generally primary (non-rechargeable) batteries that have lithium metal or lithium compounds as an anode.

### How do you ship lithium ion batteries?

Goods must be labelled as "Lithium Ion Battery" or "Lithium Metal Battery" and include appropriate shipping marks and hazard labels. Lithium batteries must have the correct documentation - including a Dangerous goods declaration, air waybill, and packing list. Can you Ship Lithium-ion Batteries Internationally?

### Are lithium-ion batteries safe to ship?

Things to consider when shipping lithium-ion batteries Because lithium-ion batteries are typically contained or encased within the equipment or products they power, smartphones, tablets, and laptops, they are considered safe to transport, as long as the metal or alloy cell in the battery does not exceed 1g.
