What is Colombia's power system like?

Colombia's power system is characterised by large installed capacity for hydropower(70% of total capacity), mostly from plants with significant reservoir capacity. VRE generation capacity, below 1% in 2017, would reach 17% by 2030 under the revised energy plan (UPME,2018). Additional biomass power by 2030 would account for 3% of capacity.

Why did Colombia impose power cuts in 2024?

Colombia's government on Tuesday, April 23,2024, rolled out new incentives to reduce electricity consumption in the South American nation, which has been hit by a severe droughtthat has diminished the capacity of local hydroelectric plants and brought officials close to imposing power cuts. What energy projects are being implemented in Colombia?

The Inter-American Development Bank has currently one energy project under implementation in Colombia, the Porce III Hydroelectric Power Plant, owned by Empresas Pú blicas de Medellí n and approved in October 2005. This is a US\$900 million project, of which the IDB is contributing US\$200 million.

Will Colombia's hydropower system be flexible in 2030?

While system flexibilty was suficient, coal and oil use rose to compensate for less hydropower output. This meant higher system costs and carbon dioxide (CO 2) emissions. Colombia is not expected to face flexibility issues in 2030even with lower rainfall.

Who supervises the provision of public services in Colombia?

The provision of public services (water, electricity, and telecommunications) to final users is supervised by the independent Superintendency for Residential Public Services, or SSPD. Colombia has 66 registered electricity producers.

Are transmission losses still a concern in Colombia?

Losses in transmission and leaks are still a concern, even if the total amount has decreased in the last years. Distribution losses in 2005 were 16 percent, compared to 13.6% average in Latin America and the Caribbean (LAC). Colombia has had a liberalized energy market since 1995.

Power factor. The customer will at all times maintain a power factor of not less than 90% lagging.
