Do Timor-Leste businesses experience electricity outages?

Research shows that nearly all businesses in Timor-Leste experience electricity outages, in some cases multiple times a week. Outages affect businesses in different ways: For tourism businesses, it impacts customer experience (internet, device charging, air conditioning and fans, food quality, and inability to refuel diving tanks).

Is there a market for roof-top solar energy systems in Timor-Leste?

Australia's Market Development Facility (MDF) and ITP Renewables conducted an assessment of the potential market for roof-top solar energy systems in Timor-Leste.

Does Timor-Leste have electricity?

Timor-Leste has rapidly expanded electricity access to more than 83 per cent of the population but the country has yet to achieve energy security.1 Consumer costs, even with government subsidy, remain high and outages are common. In addition, most of Timor-Leste's electricity is generated through costly and polluting diesel generators.

How much does diesel cost in Timor-Leste?

The price of diesel-fueled electricity generation in Timor-Leste is estimated at \$0.42/kWh. The government's diesel import bill increased from \$40.8 million in 2017 to a budgeted amount of \$109.0 million in 2020. The 2021 EDTL budget is \$148 million, of which 80% is for diesel fuel.

Does Timor-Leste have oil & gas reserves?

Since 2004,the exploitation of offshore oil and gas reserves has dominated economic activity in Timor-Leste. Petroleum revenue has on average provided a third of gross domestic product and financed 90% of the budget.

Is Timor-Leste a good country for solar energy?

Timor-Leste has a high-quality solar resource. The global horizontal irradiance in Dili is higher than on the east coast of Australia, where the solar market is mature and installation costs are higher. The cost of electricity in Timor-Leste for commercial and industrial consumers is high compared to ASEAN countries.
