Where is natural gas found in Cyprus?

Natural Gas Discoveries The first natural gas discovery in Cyprus' EEZ was made in 2011 by US firm Noble Energy and Delek Group in the Aphrodite gas field offshore Block 12, which is estimated to have 4.5 trillion cubic feet (tcf) of gas. Following a successful appraisal programme, Aphrodite was declared commercial in 2015.

Is natural gas a new industry in Cyprus?

Natural gas discoveries in both the Exclusive Economic Zone (EEZ) of Cyprus and its immediate neighbourhood over the last decade have spurred on a new industry in Cyprus providing new opportunities for business and foreign investment.

Will Cyprus find its first offshore gas in 2022?

Cyprus reported its first offshore gas discovery in 2011,but it is one of the newer discoveries in 2022- by a partnership of Italy's Eni (ENI.MI) and France's TotalEnergies - which is likely to be developed first,Commerce,Industry and Energy Minister George Papanastasiou told Reuters.

When will Cyprus' largest energy infrastructure project be completed?

Construction of the terminal at Vasilikos started in July 2020, and even though it has been beset by problems and delays, completion is expected by the end of 2024. To date this is Cyprus' largest energy infrastructure project.

When will Cyprus get a gas pipeline?

Based on reaching an agreement this year, first gas is expected in 2028, and according to the Energy Ministry it would be the biggest infrastructure project ever undertaken in the Republic of Cyprus. Currently, Cyprus and Egypt are committed to the plan.

What are some potential gas discoveries in Cyprus?

Other potential gas discoveries include Aphrodite, which holds an estimated 3.5 tcf. Development of that field was held up after a consortium led by Chevron (CVX.N) submitted a modified plan last year which Cyprus said went back on a 2019 agreement to include a floating production unit.
