### Will Namibia become a supplier of energy?

Once Namibia has successfully incubated the green hydrogen economy, it will enable the country to become a supplier of energy, rather than an importer.

#### How will solar power benefit Namibia?

The generation of solar power will complement Namibia's available green energy portfolio, such as hydro-electricity, which already constitutes more than two-thirds of our installed power capacity. Our economy is heavily reliant on the agricultural sector, which employs more than 20% of our labor force. Namibia experiences recurrent droughts, the most recent of which have been recorded as the worst in history.

### Does Namibia have a vision of shared prosperity?

As Namibia embarks on this new frontier, it is imperative that its vision of shared prosperity on the national, regional and global levels is realized. Meaning that we do not neglect those without access to political and economic power today nor exclude those who currently rely on carbon fuels.
