Does Papua New Guinea have a coherent framework for implementing ngdps?

In the absence of any coherent framework guiding the implementation of the National Goals and Directive Principles (NGDPs) in the preamble of Papua New Guinea's (PNG) constitution, their interpretation is left to PNG's public officials. These officials will not always agree on the intentions of the NGDPs.

Does Papua New Guinea have a social security system?

The agrarian lifestyle of Papua New Guineans, as in other parts of Melanesia, has been the basis of communal societies' social security in times of uncertainty in the formal economic sector. Mining, and the extractive sector of the economy in general, also features in the CPC report.

What is the Papua New Guinea national research institute (png nri)?

The Papua New Guinea National Research Institute (PNG NRI) is an independent statutory authority established by an Act of Parliament in 1988 and confirmed by the IASER (Amendment) Act 1993. PNG NRI is mandated by legislation to carry out independent research and analysis on development issues affecting PNG.
