Will Hitachi energy supply a battery energy storage system in the Faroe Islands?

Hitachi Energy has been selected to supply a large-scale battery energy storage system (BESS) for a wind farm in the Faroe Islands, as the remote archipelago targets a goal of 100% renewable energy. The North Atlantic islands, between Norway and Iceland and north of Scotland, are home to about 50,000 people.

What is Sev doing in the Faroe Islands?

"The pumped storage systemin Vestmanna is the greatest project that SEV has ever initiated, and it is likewise one of the most impressive projects the Faroe Islands have seen," the company said. According to the International Renewable Energy Agency, the Faroe Islands had around 59 MW of renewable energy installed by the end of 2021.

How many municipalities does Sev serve on the Faroe Islands?

SEV currently serves 29 municipalities on the Faroe Islands. It owns the archipelago's electricity grid and 98% of its total installed electricity production capacity, including a 261 kW solar power plant inaugurated in December 2019.
