

Is Afghanistan a WEC member?

The World Energy Resources report covers 12 major fossil fuel and renewable sources, with national assessment for all of the WEC's member countries. However, Afghanistan is not WEC's member but same to those countries, its energy resources cover both fossil fuels (non-renewables) and renewables (see Table 3).
