What is Guernsey's Electricity strategy?

In September 2023 The States of Guernsey agreed the Electricity Strategy. This detailed document covers the period up to 2050 and sets out a high-level strategic plan of how Guernsey could meet the anticipated increase in demand for electricity.

Will Guernsey Electricity invest in a new power station?

It allows Guernsey Electricity to invest in new diesel generators for the power stationand investigate a new cable from France to Guernsey. Mr Roffey warned that unless the States made a decision on the future location for Guernsey's inert waste, there would not be space on the reclaimed land at Longue Hougue for a new power station.

When did Guernsey start using electricity?

In 1898Edmundsons Electricity Corporation was granted the concession to build and operate an electricity supply in Guernsey. 7 kilometres (4.3 mi) of cables would have to be installed below ground within two years. In February 1900 150 kW could be generated from the power station at Les Amballes, St Peter Port.: 6-7
