

Who owns innargi?

Why are we here Innargi was founded in 2017 by A.P. Moller Holdingin order to examine whether competences from many years in oil and gas could help unlock the potential of geothermal energy for district heating. Today,Innargi is jointly owned by ATP (Denmark's largest pension fund),NRGi (customer-owned utility company) and A.P. Moller Holding.

What does innargi want?

Innargi wants to heat millions of urban homeswhile leaving zero impact on our planet by unearthing geothermal energy. Our natural world is precious, and we can all make small changes to the way we live. But what our climate really needs is change at scale. Solar and wind have already transformed how we produce energy.

Can innargi industrialise geothermal district heating?

Innargi and the district heating companies VEKS, CTR, and HOFOR have agreed to look at the options for the development of geothermal energy. In order to industrialise geothermal district heating, new methods and ideas had to be brought to the table.

Will innargi build a geothermal plant in Aarhus?

Innargi will build and operate the 110 MW geothermal plant. In 2025, the plant may begin to supply heat to the people of Aarhus, and the plant is scheduled to be fully expanded by 2030, when it will cover approx. 20% of the district heating demand.

Will Fjernvarme Horsens and innargi develop geothermal energy?

District heating company Fjernvarme Horsens and Innargi have entered into an agreement to investigate the possibilities of establishing geothermal energy. Innargi and the district heating companies VEKS, CTR, and HOFOR have agreed to look at the options for the development of geothermal energy.
