### Will Kuwait raise its oil production capacity in 2035?

Kuwait has had long-term plans to raise its oil production capacity to 4 million barrels per day,now targeted for 2035,with 3.65 mb/d coming from its main upstream entity Kuwait Oil Company and the remaining 350,000 b/d from Kuwait's half of the Partitioned Neutral Zone it shares with Saudi Arabia.

#### Does Kuwait have oil and gas companies?

While Kuwait's oil and gas sector is also home to non-government owned companies, their operations are largely outside of the country. For instance, Kuwait Energy is a subsidiary of Hong Kong-listed United Energy Group, which maintains exploration, development and production assets in Iraq, Egypt, Oman and Yemen.

#### How can Kuwait improve its oil industry?

In the downstream oil sector, Kuwait will need to ensure that its refineries, through upgrades, such as desulphurization and related secondary processing improvements, meet global demand for clean and high-quality oil products. Kuwait's economy is heavily dependent on oil-export revenues, with the share of revenue in GDP topping 40% in 2017.

#### Who controls the oil sector in Kuwait?

The government of Kuwaitowns and controls all development of the oil sector. The Prime Minister heads the Supreme Petroleum Council (SPC), which oversees Kuwait's oil sector and sets oil policy. The other members of the council (six ministers and six representatives from the private sector) all serve three-year terms, and are selected by the Emir.
