

Which energy storage facilities will provide Lithuania with instantaneous electricity reserve?

The Government of the Republic of Lithuania appointed Energy cellsas the operator of the storage facilities that will provide Lithuania with an instantaneous electricity reserve. Energy cells signed a contract with the winning Siemens Energy and Fluence consortium. Energy storage facilities system design works were started.

When will energy storage facilities synchronise with the CEN?

The energy storage facilities system will provide instantaneous isolated operation electricity reserve and will provide isolated operation reserve service until the synchronisation with the CEN in 2025. If needed,high-capacity reserve storage facilities will start supplying power immediately,within 1 second.

What is energy cells?

Key stages of the project Energy cells,a special-purpose wholly-owned subsidiary of EPSO-G Group,was established. An international tender was launched for the design,manufacture,and installation of a battery energy storage facilities system,as well as for technical support services for the works of the Lithuanian electricity system.
