What is the energy policy of Trinidad and Tobago?

The Government of Trinidad and Tobago is currently developing a national energy policy green paperthat recognises renewable energy's (RE) combined with energy efficiency (EE) and utilisation of compressed natural gas in the transportation sector, inter-alia, as important strategies for the promotion of sustainable development of the nation.

Why is energy security a priority for Trinidad and Tobago?

Energy security is a priority for Trinidad and Tobago. Accordingly, we have set in train steps to optimise the exploitation of our oil and gas resources while mitigating the emission of greenhouse gases and adopting low carbon solutions.

Is biomass a source of electricity in Trinidad & Tobago?

Traditional biomass - the burning of charcoal, crop waste, and other organic matter - is not included. This can be an important source in lower-income settings. Does Trinidad and Tobago have a power generation capacity?
