

What is a strategic collaboration agreement between totalenergies and gentari renewables?

What will gentari do for Petronas?

What is gentari doing with renew?

Among these collaborations is Gentari's partnership with ReNew to develop 5 GW of renewable energy in India and its joint venture with Japan's Asahi Kasei and JGC for green hydrogen production using a 60 MW alkaline water electrolyser.

Who is gentari solar Australia?

In Australia, Gentari's acquisition of WIRSOL Energy, now known as Gentari Solar Australia, marked its entry into the country's renewable energy market. The company also expanded into offshore wind with an investment in the Hai Long project off Taiwan's Changhua coast.
