

Who is Vitol?

Where does Vitol supply marine fuel?

Vitol supplies marine fuels from key strategic locations including some of the largest bunkering hubs across the globe. Vitol invested in SUN Mobility in 2021 and as of today, SUN Mobility has successfully deployed a network of over 160 Swap Points catering to roughly 5,000 electric vehicles across 18 cities in India.

Is Vitol a winner of the energy crisis?

Vitol, the world's largest independent commodity trader, has emerged as one of the biggest winners of the energy crisis, reporting record profits far in excess of its rivals. The privately owned group, whose top executives are largely based in London, made almost \$15bn of net profit in 2022, according to people familiar with the matter.

Does Vitol have a power plant in the UK?

In 2013, Vitol invested in its first power plant, VPI Immingham in the UK. The combined heat and power plant (CHP) is one of the largest of its kind in Europe, capable of generating 1,240 MW and up to 930 tonnes of steam per hour which is used by nearby refineries. The gas-fired plant provides approximately 2.5% of UK peak electricity demand.

Who owns Vitol?

Vitol, through its wholly owned subsidiaries Arawak Energy Limited and Vitol E&P, has interests in various exploration and production projects worldwide.

Is Vitol a Russian oil company?

Vitol is a Dutch-registered company, with large offices in Geneva, London, Houston and Singapore. The group is the world's largest independent oil trader, though it traded slightly less crude last year than in 2021 after curbing the volumes of Russian oil it handled. Vitol stopped trading Russian crude in June.
